WAIVER OF LIABILITY, RELEASE, ASSUMPTION OF RISKS, INDEMNITY AGREEMENT,

CONSENT TO TREATMENT, AND COVENANT NOT TO SUE

The undersigned Participant hereby releases, exempts, waives, and relieves the Great Falls Community Ice Foundation and Great Falls Ice Plex staff, together with their respective administrators, directors, managers, agents, employees, contractors, affiliates, sponsors, advertisers, ice officials, legal representatives, organizers, volunteers, workers, promoters and their respective successors and assigns (collectively, "RELEASEES") from and with respect to any and all liability for personal injury, property damage, wrongful death, and all other claims of any nature, whether at law or equity, INCLUDING CLAIMS RESULTING FROM RELEASEES' NEGLIGENCE, arising from or in any way related to the undersigned's participation in or attendance at the Electric City 3v3 Hockey League (the "League").

Participant warrants that he/she is in proper physical condition to participate in the League, and acknowledges, understands, and assumes all risks relating to the League, ice hockey generally, and any member team activities. Participant also understands that ice hockey and related activities include foreseen and unforeseen risks to Participant's person, including bodily injury, partial or total disability, paralysis and death, and damages that may arise therefrom. Participant acknowledges, understands and assumes the risks arising from the conditions and use of ice hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action (including any cause of action based on RELEASEES' negligence) arising from the performance or failure to perform maintenance, inspection, supervision or control of said areas and the failure to warn of dangerous conditions existing at said rinks and adjacent areas and facilities. Participant also hereby consents to such medical treatment, as officials deem necessary, in the event that Participant becomes ill or is injured at the League facilities. Participant also understands that the League and related activities may be photographed, filmed, or recorded, and consents to RELEASEES' use and publication of Participant's photograph, audio recordings, or other depictions or publications concerning the League.

This Waiver of Liability, Release, Assumption of Risks, Indemnity Agreement, Consent to Treatment, and Covenant Not to Sue ("Release") shall be governed by the applicable laws of Montana, and Participant agrees that any legal action concerning the effect of this Release or the subject matter hereof shall be adjudicated only in the federal or state courts of Montana, and in no other jurisdiction. If any part of this Release is determined to be unenforceable, all other parts shall be given full force and effect. Participant also covenants not to sue RELEASEES, and further agrees that if any claim for Participant's personal injury or other damages is commenced against RELEASEES, Participant shall DEFEND, INDEMNIFY AND HOLD RELEASEES HARMLESS from and with respect to any and all claims or causes of action by whomever or wherever made or presented, including defense costs and legal fees. Participant further acknowledges that he/she has read and understands the meaning of this document and has not relied upon any representations of RELEASEES, and that he/she is fully aware of the potential dangers of ice hockey and related activities.

The Great Falls Ice Plex will continue to take precautions related to COVID-19 and follow any local or state mandates that may be put into place. Anyone who is experiencing COVID symptoms should stay home. Symptoms of COVID-19 include fever, fatigue, cough, difficulty breathing, loss of taste/smell. By signing below, I agree to the following:

- Neither I nor any members of my household will enter the Great Falls Ice Plex if:
- We have been diagnosed with COVID-19 or have had a positive COVID-19 test within the past 10 days.
- We have knowingly been exposed to anyone diagnosed with COVID-19 within the past 10 days.
- I will follow any and all Great Falls Ice Plex policies and regulations, including those related to COVID-19. If I refuse to do so, I will be ejected from the League, asked to leave the facility, and not be given a refund for any remaining sessions.
- I understand that the Great Falls Ice Plex and the Great Falls Community Ice Foundation cannot be held liable for any exposure to the Sars-CoV-2 (COVID-19) virus.
- I release the Great Falls Ice Plex and the Great Falls Community Ice Foundation from any and all liability for unintentional exposure or harm due to COVID-19.

3v3 HOCKEY LEAGUE RULES:

This league is provided by the Great Falls Ice Plex for pre-season hockey skill development. The league is meant to be fun, not competitive. Sharpen the rust off your skates & come out and play some hockey!

- **TEAMS**
 - **Only individual registrations will be accepted**
 - **Drop-in players will NOT be accommodated**
 - **Team composition will vary from game-to-game**
 - **Players should bring a light and a dark jersey to every game**
 - **Each team may comprise up to 7 players (up to 6 skaters + goalie)**
 - **Players will be divided equally into age divisions once registration is complete.**

- **CONTACT**
 - **No checking is allowed**
 - **Excessive contact is prohibited**
 - **Players involved in a fight or altercation will be ejected**

- **SHOOTING**
 - **No slap shots**
 - **Shots must be kept under control at all times**

- **GEAR**
 - **Full hockey gear is required**
 - **Youth players are required to wear mouthguards**

- **GAME**
 - * **No players on the ice during resurfacing. All players will remain OFF the ice (unless helping with nets) until ALL doors to the ice are closed**
 - **Games will be played cross ice**
 - **Full size nets will be used if goalies are available; goalies are encouraged to participate!**
 - **25 minute run time**
 - **Game start times will be announced once registration is complete; games will not start earlier than 6pm**
 - **Younger age divisions will play first each evening**
